MIN 11/23-24 -REMARKS ON DEVELOPMENT CONTROL

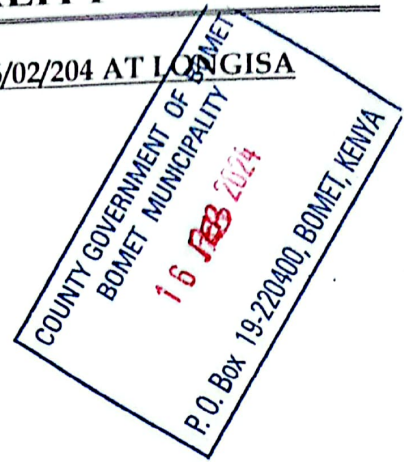

The community made remarks on proposals to be considered in the Municipality which are listed below;

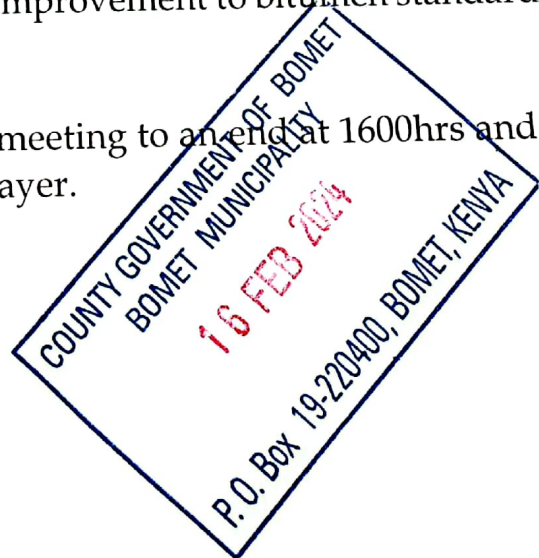
- a) Completion/construction of Longisa market
