Min 1.14/11/2018: Opening prayer and introduction.

The municipal chair welcomed all to the meeting and after a prayer by Josphine Chepkirui then followed a session of self-introduction by the county staff and members of the municipal board present

Min 2.14/011/2018: Municipal board sensitization.

The chair started by informing the meeting on the highlights of the role of the Bomet municipal board and functions while using an example of how the defunct local authorities worked.

The chair expresses his hope that the executive would soon deploy staff to work under the municipal, as this will ensure that the functions of the board are performed as expected.

The chair emphasized the need for the members of the public to take part in shaping their own destiny through making contribution in projects and activities that affects them.

He went on to inform members that the meeting had been convened to come up with amicable solutions to challenges faced by residents of the municipality.

Min 2.15/11/2018: Proposed KUSP projects. the director urban planning pointed out the various grievances which the Bomet town residents have been raising to her excellency the governor; the issue of mud in the lower market, the business volumes are too low because buyers are not willing to purchase from a muddy place.

- 1. The meeting agreed with the proposal that construction of cabros for the lower market be prioritized.
- 2. The pot holes in the CBD which had adversely affected traffic flow will be re-carpeted. This will ensure smooth flow of traffic within the CBD
- The open drainage with stagnant water will be a thing of the past, drainage within the CBD will be improved and covered so that parking bays are created.
- 4. It was further proposed that solid waste management system will be enhanced through provision of litter bins, transfer stations, and tractor with skip loader. The residents were advised to manage the garbage at source.

Min4.14/11/2018: Comments from Director of Enforcement.

The Director of Enforcement informed the meeting that security responsibility was to ensure that every vendor in the market should get enough security and also enjoyed a clean and healthy environment. He said that due process was followed in the implementation of security as required by the law.

Min4.14. /011/2018 comments from the chairman

The Chairman finally thanked all the members who were present for their participation in the meeting. And also pointed out that it was necessary to ensure that everyone take responsibility by contributing positively

Min5.14/11/2018: VENDORS SELLING OUTSIDE THE MARKET

Having in attendance some of the vendors selling outside the market it was then agreed in the meeting that they should be allocated open space and also for those supplying various hotels and restaurants to operate from inside the market.
