Min 1/2/2019: Preliminaries.

- 1.** Opening prayer by Jonah Rotich.
- 2.** Introduction: the board and key stakeholders and some participants made self-introductions

Min 1/2/2019: opening remarks by the chair.

The chairman introduced the ongoing KUSP projects:

1. Storm water drainage
2. Recarpeting of 1.5 km CBD road
3. Cabro works and extra stalls for the new market
4. Extension of sewer line
5. Supply and delivery of solid waste equipments

The chair made a passionate appeal to businesses and individuals; those directly and indirectly inconvenienced by the ongoing projects to bear with the situation for a better tomorrow; efforts were being made to mitigate on how best the effects can be minimised

Min 2/2/19 – Presentation by County NEMA Office.

The officer advised that each landlord should put in place a receptacles where the garbage will be deposited awaiting transfer to designated place can be done at a cost.

- The garbage sorting/segregate can be a business opportunity.
- He emphasized that people should comply with the laid down regulations on use and dispose of waste to avoid hefty penalties.
- Pigs can be kept to devour waste from the hotels this is a good business opportunity.
- Individual can start up garbage collection at estates as a business venture

RESOLUTION: It is the responsibility of every resident especially the landlords and the tenants to ensure that Bomet is kept tidy. The meeting resolved that the business including residential areas must put up the necessary receptacle by **3rd June 2019**. Those who fail will face penalty/ pay a fine as per NEMA regulations. The participants of the meeting requested one more meeting with the Board members and NEMA before the order to put in place receptacles by the land lords takes effect

Min 3/2/19 presentation of KUSP projects.

Engineer Cornelius Ngeno made presentations on three KUSP projects for 2019/20 as follows;

- Upgrading to bitumen standards of 1.5 km of silibwet selected access roads

- Connection of Bomet University to chebirir to highway through the grading and improvement of the road to bitumen standards.
- Improvement of the working environment in the market by having cabro works to cover all the market.

The participant supported the submitted proposals. Other concerns were raised on how the current works on the drainage system will work.

- Existing drainage versus expanded storm water drainage. The participants were taken through the design to understand the ultimate results and benefits of the improved drainage system.
- The existing receptacles holds water and this makes it to rust so quickly. There should be holes on the bottom to let out water.
- Excavation without timely back/filling cabro work progress too slow. The contractor should be sanctioned immediately.
- Complaints – Daily wages offered by Patience contractor in charge of cabro and market stalls is too low.
- Non timely payments to the casuals by the contractors. The contractor should ensure that the contractors are paid on time.
- Complain on discharge of raw sewerage by landlords. The NEMA officer and public officers should carry out routine inspection and sanction those responsible.
- Heaps of soil at cabro site which was excavated has not been taken away,
- Sewer Water siphoning through jua kali sheds requires the attention of health officials.
- The users of economic infrastructures requested to be involved during the design stages of the projects.
- Access road should be provided to connect the upper with the lower market; this ensures that the customers crosses the two markets with ease.

The participants of the meeting resolved that the social audit by the residents of Bomet should prevail and may request the contract managers to sanction the contractors before contractors are paid any dues.

Min 4/2/2019: Any Other Business

The board chair on Roads and infrastructure announced that members will carry out a site inspection two months after the commencement of the projects. The technical team in charge of the projects will accompany the board committee members to elaborate/make the necessary explanations on matters likely to raise concern.

The meeting was closed with a word of prayer from Jonah Rotich at **3.30pm**.
