# MIN 01/3/019 - PRELIMINARIES

# MIN 02/03/2019; MATTERS ARISING FROM PREVIOUS MINUTES;

The members noted that they should be issued with an up to date implementation schedule for all projects copies of the projects documents in their files; the secretary was asked to ensure that this order is complied with before the next board meeting.

The meeting also noted that the technical team should liaise with the committees of the board when planning for the inspections and site visits of all the projects. A concern was also raised that the contractor for sewer line extension has been disconnecting utilities like water and roads without adequate preparations to restore the services within a short time. This has brought about a lot of complaints which is likely to derail or slow down the progress of the project. It was resolved that the contractor of the said project should liaise with the department of water to mitigate the damages caused by the project on other utilities.

# MIN 2/3/2019: MUNICIPAL STAFF:

It was resolved that the functions of the low cadre staff be transferred to the board including the staff while the senior staff should be seconded until the Public Service Board substantially hires staff for the municipality.

On A.O.B, the issue of member's allowances was deliberated on, it was felt that, what the SRC proposed is peanut as compared with their mandate.

The members made the following proposals on their allowances

- Retainer allowance- 150,000
- Sitting allowances –Chairman -20,000
- Vice Chairman -18,000
- Other members -15,000

It was further resolved that a comparison should be done to find out how other board members are remunerated. The secretary was tasked to provide SRC circulars on remuneration of other board members. The members expressed their concerns that their remuneration was not proportional to their mandate as provided in UACA act. The members asked the chair to make a better bargain on the municipal board members remuneration during the upcoming Chairperson's Caucus on **29th march 2019 in Nairobi**.

# MIN 03/03/2018 CITIZEN FORA;

The members proposed that the citizen for should only be held after the municipality has assigned with basic staff so as to deal firmly with the implementation issues.

# MIN 04/03/2019: CONSULTATIVE FORUM ON THE ONGOING KUSP PROJECTS IN BOMET TOWN.

The meeting noted that the ongoing KUSP projects were inconveniencing business adversely. The members observed that there was a need to have a consultative meeting with the business persons and other stakeholders in Bomet town to enable them to understand that they should bear with the situation for better future of Bomet town.
